MKR Dental Cabinets Lifetime Limited Warranty

MKR Dental Cabinets warrants to the original dental purchaser for a period of 10 years from the purchase date that MKR Dental Cabinets products will be free from defects in material and workmanship under normal use. This warranty is only applicable to products used in dental applications within Canada and is transferable to subsequent owners. If installation of these products is completed by an authorized MKR Cabinet Installer, the installation workmanship will be warrantied for a period of one year to be free from defects.

Should defects in material or workmanship exist during the applicable warranty period in any MKR product, MKR will elect at its discretion to either repair or replace the defective materials. This warranty covers only parts and materials of the products supplied by MKR. Not covered under this warranty are Accessories incorporated within the cabinetry as they fall within the specific warranty granted by the manufacturer of the Accessory. These accessories may include; clock/timers, lighting, monitor and keyboard mounts and swing arms, sinks, plumbing fixtures, remote and toe controllers, fans, humidistat or temperature sensors, and other accessories itemized within the order(s), or the cost, including labour, to remove and reinstall Accessories. Not covered under this warranty are costs of materials and labour indirectly impacted by completion of the warrantied materials and workmanship, including but not limited to wall coverings, counter tops, flooring, or the costs, including labour, provided by the necessary support from an electrician, plumber, or equipment technician to remove and reinstall materials and related components.

This warranty shall become void if the cabinet products are in any way modified, improperly installed or damaged prior to or during the installation by any individual who is not an authorized MKR Cabinet Installer. Furthermore, this warranty will not apply to cabinets damaged by misuse, neglect, abuse, acts of God, exposure to extreme temperatures, normal incidental deterioration such as nicks, scratches, abrasions and natural aging whether resulting from the effects of normal wear and tear or abnormal use. Natural woods may vary in color, characteristics and exhibit subtle changes as they age. For example, painted five piece doors may eventually have visible cracking around the joint area. Cabinet colors may darken or lighten over time. Sunlight, smoke, cleaners and other environmental conditions may also affect the color match over time. These variations are considered to be the nature of the material in relation to their environmental exposure and are not covered under this warranty. PLEASE CONTACT MKR ABOUT WOOD AND FINISH SPECIFICATIONS, AS WELL AS HUMIDIFICATION GUIDELINES AND CUSTOMER CARE SUGGESTIONS. MKR reserves the right to alter design, specifications and material without obligation to make similar changes to products previously manufactured.

The repair(s) or replacement(s) are contingent upon the current product offerings of styles and construction options within the MKR products at the time of the warranty claim. If a warranty claim is filed after a MKR product becomes obsolete, MKR reserves the right to honor the warranty in one of the following fashions:

- 1. To replace the affected component with a new component of the same style.
- 2. To replace the affected component and any other component(s) in the immediate dental application space to achieve a uniform appearance with a similar and comparable product style of the originally purchased style.

If components are replaced, MKR cannot guarantee that the finish of these replacements will exactly match the finish and appearance of the components in the dental application. This is due to the changes that occur during the woods' natural aging process, affecting its color and grain.

This warranty sets forth your sole and exclusive remedy as a warranty holder for any non-conformity in a cabinet product. In no case will MKR be liable to you or to any other person or business for any consequential, special, or indirect losses or damages of any kind. THIS LIMITED WARRANTY IS IN LIEU OF AND MKR DISCLAIMS ALL OTHER WARRANTIES, EXPRESS OR IMPLIED, INCLUDING BUT NOT LIMITED TO ANY IMPLIED WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE. TO THE EXTENT ANY IMPLIED WARRANTIES MAY NONETHELESS EXIST BY OPERATION OF LAW, SUCH WARRANTIES ARE LIMITED TO THE DURATION PROVIDED BY LAW.
